TLIF2080 Safely Access the Rail Corridor

Course overview:

SX52 (Accessing the Rail Corridor) is an induction training package specifically designed for persons working in the Sydney Trains Network and is delivered under license to Transport for NSW. Training and assessment includes TLIF2080C (Safely Access the Rail Corridor) which is a national unit of competency developed to meet the applicable legislated rail safety requirements including acts and regulations from the applicable state or territory together with any nationally approved compliance codes and/or guidelines.

Upon successful completion of this course participants will receive a Statement of Attainment (SOA). **Please note that the SOA in itself is not enough to work in the rail corridor.**

NOTE - Following successful completion of training you must apply for and be issued with an RIW card as follows before work in the rail corridor.

Issue of RIW Card:

In order to receive an RIW card, participants must arrange with their actual/potential employer to apply for an RIW card. This requires individuals to complete the 100-point ID check via Australia Post and a registered company submitting the individual's Statement of Attainment together with page 3 of the signed medical assessment onto the Pegasus Onsite System.

(Note if you are planning to later enrol in protection officer training you should arrange a Category 1 medical instead of the Category 3 assessment)

Learning Outcomes:

On successful completion of training, participants will have an understanding of rail terminology, basic signalling indications, rules and regulations for people working in the rail corridor, knowledge of a safe place, Electrical safety, personal & legal requirements of fatigue, drugs and alcohol.

Issue of RIW Card:

In order to receive an RIW card, participants must arrange with their actual/potential employer to apply for an RIW card. This requires individuals to complete the 100-point ID check via Australia Post and a registered



company submitting the individual's Statement of Attainment together with page 3 of the signed medical assessment onto the Pegasus Onsite System.

Program Schedule: Mondays, Wednesdays and Thursdays at 0730 subject to bookings.

Attendance of a minimum 6 hours of face-to-face learning and completion of assessment tasks is mandatory in order to complete this unit of competency. Six (6) hours of face-to-face learning does not include breaks. You will be required to arrive 30 minutes ahead of the nominated start time to confirm all enrolment details are completed.

Requirement for attending Training:

To attend training on the day you must:

- **wear appropriate clothing to be able to perform in group activities and demonstrations**

Fees and Enrolment:

The course fee includes workbook and assessment material.

Participants must provide payment, a **completed enrolment form and USI number** before training day.

Note: - If you don't already have a USI it can be generated at the following location: usi.gov.au

We also provide a combined training and medical assessment package which provides a substantial cost saving if the required medical is arranged separately.

NOTE: Same day RISI Training and Medical are available at Burwood.

Assessment

Learning and assessment activities will be conducted by assessors using a range of evidence gathering techniques throughout the course, including written and practical demonstrations. Your trainer will provide you with any support you may require with your assessment throughout the training.

If you are assessed as "Not yet competent" on the first attempt, you will be given another opportunity to demonstrate your competence. If you are still not successful after this you may need to reenrol and repeat the unit of work.

Pre-requisites

This course requires you to read, write and communicate in English. If you are unable to demonstrate that you can communicate effectively in English and have the appropriate literacy levels to participate in this program you will be required to complete a simple language, literacy and numeracy test before attending training.
